# BACTON PARISH CEMETERY

## TABLE OF BURIAL AND OTHER FEES FIXED BY THE PARISH COUNCIL OF BACTON IN THE COUNTY OF SUFFOLK, ACTING AS THE BURIAL AUTHORITY FOR THE PARISH OF BACTON.

The fees and payments set out below marked 'resident' apply where the person to be interred or in respect of whom the right is granted is, or immediately before his death was, or in the case of a still-born child where the parents are, inhabitants or parishioners.

The fees marked 'non resident' apply to all other interments.

### 1. Interments (excluding all charges for labour)

In graves for which an exclusive right of burial has been granted for an initial period of 25 years. For any interment at a depth not exceeding 7 feet, the body of: -

A person whose age at the time of death does not exceed 18 years	Nil	£100

### 2. Monuments, Gravestones, Tablets and Monumental Inscriptions

For the right to erect and place
